A threadbare discussion was made on all the compliances made by the University and the following proposals were made by the IQAC for consideration of the University authorities:

1. The Vice Chancellor, Chairman, IQAC proposed to constitute an Institutional Ethics Review Board (IERB) of Sambalpur University according to the ICMR guidelines for conducting research on human subjects.
2. The Vice Chancellor suggested to create a "Digital Campus" with next generation Wi-Fi services in the Sambalpur University.
3. It was further decided by the IQAC to enter into more MoUs with other institutions/organizations/ universities both at national and international levels.
4. Requisite arrangements may be made to upload all certificates of the University in the National Academic Depository in future. In this regard the Controller of Examinations is requested to take necessary steps.
5. The IQAC proposed that the Controller of Examinations may take initiative for online form fill up and online issue of admit cards of undergraduate CBCS students of the affiliated colleges and post graduate students of our University with the help

The Committee be requested to submit yearly Evaluation Report to the IQAC for necessary follow up.


