1. The requisite amount as applicable (**given below**) be deposited through **State Bank Collect facility** (As per the enclosed *Instruction*) and e-Receipt be deposited along with other documents.

2. A Bank Draft amounting to **Rs.3,032/-** (*Rs. 1,500/- as one time Infrastructure Development Fund fee + Rs. 1532/- as one time admission fee*) be drawn in favor of "**HOD, Chemistry**" payable at **SBI, Jyoti Vihar (Code No. 6672)**.
3. A Bank Draft amounting to **Rs. 27,500/-** (*Rs. 25,000/- as Course Fee per Semester + Rs. 2,500/- as Development fee per Semester*) be drawn in favor of "**M. Sc. in Applied Chemistry**" payable at **SBI, Jyoti Vihar (Code No.6672)**.

Another Bank Draft amounting **Rs. 3,000/- (Rupees three thousand only)** be drawn in favor of the "**President, Chemistry Seminar**" payable at **SBI, Jyoti Vihar (Code No.6672)** towards Annual seminar subscription and Extra-curricular Activities Fee.
