NOTIFICATION

The Twenty Eighth Convocation of the Sambalpur University will be held on Saturday, the 6th day of January, 2018 at 10.00 A.M. in the Biju Pattanaik Auditorium of the University at Jyoti Vihar, Burla. The Doctorate degrees for the year 2017 examinations will be conferred and Gold Medals/ Prizes of 2017 examinations will be distributed on this occasion. Degrees/Diplomas for the examinations 2017 will also be conferred and distributed to the successful regular candidates including those of Autonomous Colleges through Principals of their respective Colleges and Heads of the University P.G. Departments and to the Non-Collegiate candidates through the Registrar of the University as per prescribed procedure. The Hon'ble Chancellor will preside over the Convocation.

The candidates shall submit their applications in the prescribed Form along with the fees mentioned hereinafter to the Registrar, Sambalpur University, Jyoti Vihar, Burla- 768019 (Odisha). The application form may be downloaded from the University website www.suniv.ac.in or can be obtained from the University office (EG-IV Section) on payment of Rs.10/- (Rupees ten only).

The last date for receipt of applications along with the fees in the University office is 03.01.2018. Applications and/or fees received after the above date will not be entertained.

For hiring Gowns, each recipient of Ph.D/D.Litt./D.Sc./LL.D Degree and Gold Medal is required to pay a fee of Rs.100/- and also to deposit Rs.500/- as caution money in the University office by cash in the Cash Counter. The caution money shall be refunded after return of Academic Robes to the University.
