- ii. Postgraduate degree in Education (M. Ed. Or M.A. Education) with minimum 55% marks.
- iii. Ph.D. degree in Education or in the discipline relevant to the area of specialization.
- iv. Candidate having published work of high quality and actively engaged in research with evidence of published work with a minimum of 10(ten) publications in referred/peer-reviewed journals, and as books and/or research/policy papers.
- v. A minimum of 10 years of experience in teaching in University/ Colleges and /or research at the University/National-level Institutions/industries, including experience of guiding candidate at research doctoral level.
- vi. Contribution to educational innovation, design of new curricula and courses and technology-mediated teaching learning process.
- A minimum Academic Performance Indicator (API) scores required is <u>75 in Category-I, 15 in Category-II (Category-I + Category-II minimum required score is 100) and 400 points in Category -III as stipulated under the Performance Based Appraisal system (PBAS), as set out in the UGC Regulation 2010 and subsequently amended in 2013 and in 2016.</u>
