# SAMBALPUR UNIVERSITY

## REGULATION FOR THE BACHELOR OF ARTS, SCIENCE & COMMERCE EXAMINATIONS (THREE YEAR DEGREE COURSE)

1. The three year Degree course leading to the Bachelor's Degree in Arts, Science and Commerce of Sambalpur University shall spread over a period of three academic years. A candidate for the Bachelor's Degree in Arts, Science and Commerce shall be required to pass the following examinations. *These shall be conducted at the University during the April every year*
- First Examination; and
  - Final Examination

After the first year of study, the college will conduct a class promotion examination. At the end of second year, the University will conduct the First Examination, covering the courses of both years. The final Examination will be conducted by the University at the end of the third year.

2. A candidate for the Bachelor's Degree in Arts, Science, and Commerce, under these regulations shall be required to enroll himself as a student of one of the colleges affiliated to this university. No student shall be admitted to the First Examination unless he has passed the promotion examination conducted by the college.

e 3.1 Any person, who has passed the Higher Secondary Examination of the Council of Higher Secondary Education, Orissa, or any other examination recognized by the Academic Council or CHSE, Orissa as equivalent thereto, may be admitted to the first year of this course in any of the colleges, affiliated in that stream, provided that a student shall not be admitted into Degree course in Science unless he has passed the qualifying examination in science

- 3.2 No student shall ordinarily be admitted into the first year of the course four weeks (including holidays and Sundays) after the date of the publication of the results of the Annual Higher Secondary Examination of the Council of Higher Secondary Education, Orissa or the reopening of the College after the Summer Vacation whichever is later.

- 3.3 Candidates who, for some valid reasons, are unable to take admission within the time prescribed under Regulation 3.2 above, may however be admitted into a college within two weeks (including holidays and Sundays) from the last date of admission with a late fee as prescribed by the University. The Principal of the college shall intimate the names of such candidates and their dates of admission and shall remit the late fee collected to the University in one lot within two weeks from the last date of such late admission.

- 3.4 Candidate who has taken late admission, on payment of the late fee, shall have the percentage of such admission.



3.5 Candidates passing the Supply Examination of the Council of Orissa, may be admitted two weeks (including Sundays) publication of their results may be admitted within one fee as prescribed by the University. A candidate so admitted shall lectures counted from the date having passed the +2 examination or any equivalent examination into a college shall also provision.

3.6 Admission to the third year shall within four weeks of the reopening without waiting for the publication of the First Examination. Provided that the student shall be admitted to the third year within a week (including Sundays & Holidays) late fee as prescribed by the University.

3.7. Notwithstanding any thing contained in the Regulations, where the Syndicate has seats in any class or gives fresh new subject in any college the department in this regard shall be deemed publication of results of the Council of Orissa, in respect of newly affiliated subject for publication thereto.

3.8 A candidate whose results of Higher Education are published by the Council of Orissa shall be admitted into a college within a week of publication of his results without late fee, provided that a student admitted into the +3 1st year class beyond 30 days after the last date of admission in the Regulation 3.3.

A candidate who has been admitted in particular subject(s) or combination of subjects by the Principal after the last date of admission in the Regulation 3.3.

5.1 Any registered student of the University admitted to the First Examination if he has one or more colleges admitted for the examination in the subjects which he has taken after study for not less than two years after passing the Higher Secondary Examination by the Council of Higher Secondary Education, Orissa or any other Examination recognized by the Council of Higher Secondary Education, Sambalpur University as equivalent to the Higher Secondary Examination. Such a student should also be eligible for the promotion Examination conducted by the Council of Orissa at the end of the First year and the Second Year course.

Degree in Arts, Science & Commerce if he has passed in all the papers of the First Examination in the concerned stream or appeared at the same, and has thereafter completed a regular course of study for not less than one academic year in the third year course in one or more colleges admitted for the purpose of such examination in the subjects which he offers, and sent up by the Principal of the concerned college after holding such test examination as he may deem necessary, provided he is not otherwise ineligible for appearing at the said Examination.

5.3 (a) Notwithstanding the generality of the provision of Regulation 5.2 supra, a student shall not be debarred from taking admission in ~~the~~ pursuing the course of study for the Final Examination on the ground of his not obtaining the pass marks in any or all the papers of the First Examination, but appearance at the said examination is a pre-condition and pre-requisite for being eligible to take admission to the third year.

✓ (b) A candidate failing to secure 30% marks in pass subject/paper(s) either in the First or Final Examination of this University may be allowed to appear in those subjects/paper(s) in not more than two examinations immediately following the Examinations for which he was first registered, to clear the back paper(s) on payment of prescribed fees.

✓ (c) A candidate failing to secure 45% marks in Hons. subject/paper(s) either in the First or Final Examination of this University may be allowed to appear in that subject/paper(s) in not more than two examinations immediately following the examination for which he was first registered to clear the back paper(s) or improve his performance as the case may be on payment of prescribed fees. 13876

(d) If he fails to pass in such chances the marks secured by him in all subjects/papers of such Examination shall stand automatically cancelled, and he has to appear in all the papers of that examination.

✓ (e) If the candidate does not secure the pass marks in the aggregate (under regulation 6.2) he/she may reappear in one or more subjects/paper(s) of his choice from either the First or Final Examination to make up the deficiency. This chance shall be available to a candidate in not more than two examinations immediately following the Final Examination in which he/she was first registered.

✓ (f) Candidates who have been duly admitted to BA/B.Sc. B.Com. (Hons) (3 years degree course) examination of the Sambalpur University and have passed without honours or have obtained only a Second Class can reappear in the Honours papers only to improve their results at a subsequent Annual Examination, on application submitted through the Principal of a College affiliated to Sambalpur University in the subject up to the Honours level. The higher of the marks in each paper shall be taken into consideration for determining their results and divisions.

*However distinction is earned by the candidate shall not be debarred*



Provided that a candidate shall be allowed to improve his performance only once and within a period of two years from the date of his passing B.Sc./B.Com. (3 years degree course) examination at Sambalpur University.

Provided further that in subjects where courses are offered a candidate shall undergo practical training for a period of one month and obtain a certificate at the time of submitting the application form to that effect, from the H.O.D. of a college, where such subject is taken up to the Honours level.

Note: 1. All candidates who have passed the B.A. B.Com. examination of the Sambalpur University in 1985 may avail themselves of this opportunity once and within 1992.

6.3 In each of the above examination, a candidate must have secured a minimum of 40% in each practical subject.

✓ 6.4 In each of the above examinations, if a candidate passes in the aggregate in all subjects excepting in the practical examination in one subject only of the subjects other than Honours, his deficiency in the practical papers shall be diminished in addition of one mark for every 10 complete marks secured by him in the corresponding theory papers in excess of the minimum pass marks subject to a maximum deficiency of five marks and the number of marks by which he/she has failed in the practical examination shall be deducted correspondingly from the marks obtained in the theory papers.

7.1 (a) The examination in Arts, Science or Commerce shall be conducted by means of written papers and the same papers shall be used at every place at which the examination is held.

(b) There shall be a practical examination in all subjects in which it is prescribed.

7.2 The duration of examination for each theory paper carrying 50 marks shall be two hours, and for each theory paper carrying 75 or 100 marks, it shall be 3 hours.

7.3 The laboratory note-book or the field-work note-book of each candidate who offers a subject in which there is a practical examination, shall be inspected by the Examiners who shall take those into consideration which determines the results of the practical examination. Each experiment in every note-book shall contain the date of the experiment, signature of the student and the initial of the teacher with date under whom the experiment was performed.

7.4 The question paper for the University examination in Arts, Science or Commerce shall contain alternative questions on the courses of study prescribed for the preceeding year where such courses of study have since been altered or amended.

8.1 The courses of study for the Bachelor's Degree Examination (Pass and Honours) in Arts, Science or Commerce shall consist of the following components:

- i) Foundation Course
- ii) Core course
- iii) English/M.I.L. Compulsory Core Course.
- iv) Ancilliary/Applied course.

8.2 The Modern Indian Language shall be any one of the following :-

Oriya, Telugu, Bengali, Urdu, Hindi.

If the mother tongue of the candidate is a language not included in the above list he shall have an alternative paper in English of a Higher Standard. A candidate may also be permitted to take up one of the

- 10.1 A candidate shall be required to attend 75% of lectures, tutorial and practical classes, taken separately, in each subject, during each academic year and condonation in exceptional cases may be granted by the college to the extent of 15%

- 10.2 The Syndicate may grant further condonation of attendance to the extent of 5% in respect of students who represented the University or State competition for any inter-university or national competition, games or sports, to be recorded in writing.

- 10.3 A candidate may be permitted to take up one course as specified under clause 8.2 of these regulations without the requirement of attendance at the college in which he or she is admitted is not in that subject.

- 11.1 Candidate for admission to the First Examination Final examination in Arts, Science or Commerce specify the subject or subjects including the paper(s), as the case may be in which he desires to be examined for the pass and Honours Examination. The form of application prescribed for the purpose.

- 11.2 The form of application submitted by every candidate for admission to any examination, other than the subject(s)/papers in Arts, Science or Commerce, must contain a certificate of the candidate's (i) character, (ii) diligent study (iii) having maintained the required percentage of attendance in each course and (iv) having satisfactorily passed the previous examinations conducted by the college. The certificate must be duly signed by the Principal or in any case by the college authorised for the purpose by the Principal. Failure to earn any of the above mentioned marks from the Principal of the college will disqualify the candidate for being admitted to the next examination till he earns the same.

Provided that a candidate seeking admission to any examination under Regulation 5.3 (Clearance) must obtain a certificate

11.3 A candidate who has earned the certificates mentioned in Regulation 11.2 supra, but for some valid reason as certified by the Principal, has not submitted his application with prescribed fee in due time for the examination for which he is eligible, may be allowed to register himself for the examination on payment of late fee as prescribed by the Syndicate from time to time in addition to the prescribed examination fees.

11.4 The fees payable for registration/admission to any examination, under these regulations shall be as prescribed from time to time.

✓ 11.5 If a candidate has paid full fees for all the subjects in any examination, but remained absent in all the subjects, he shall be required to pay the full prescribed fees if he appears at the same examination again in the subsequent year(s).

✓ 12. A candidate taking Honours course initially in a subject may choose in writing to drop the Honours course and adopt the pass course in the same subject at the time of submitting his application for the First examination or Final Examination or earlier, and he would then appear at the pass course examination in the subsequent examinations.

Provided, however, that if the candidate changes from Honours to Pass in a subject at the final examinations, average percentage of the marks obtained in the papers of the Honours subject at the First examination shall be treated as the marks obtained in the Pass subject at the corresponding examination to determine his result.

✓ 13. Any candidate who has been registered as such in any other University of the State will be permitted to migrate to this University and to register either for the First Examination or for the Final Examination of this University. In such a case, the marks obtained by him/her in the First Examination of the other University will be taken as the marks obtained by him/her for the result. ~~First Examination of the other University will be taken as the marks obtained by him/her for the result.~~ However, the privilege of back paper clearance shall not be allowed to such a candidate in respect of the examination of the other University.

14.1 The results of the three year B.A./B.Sc./B.Com. degree examination and the classes to be awarded shall be determined on the basis of the combined results of first Examination and Final Examination taken together.

✓ 14.2 (a) As soon as possible preferably within 45 days after the completion of Final Examination (Theory papers) the Syndicate shall publish a list of successful candidates based on the marks of First and Final Examination.

(b) There shall be separate lists for candidates of Pass and Honours in each stream of Arts, Science and Commerce.

(c) The list of the



(d) Candidates who pass in their 1st appearances in one session will be placed above those who pass back paper clearance in the merit list.

(e) The list of candidates who pass the Pass course shall be arranged college-wise according to the roll numbers. In case a candidate has obtained Distinction it shall be mentioned against his/her name.

14.3 Each successful candidate at the Final examination of the 3 year degree course shall receive a diploma in prescribed form signed by the Vice-Chancellor.

15.1 For B.A.(Pass) & B.A.(Hons.) each period shall be a maximum of 50 minutes duration. Each practical class may cover a minimum of 3 periods. Each tutorial & Practical group will consist of a maximum of 16 students. A general class will have a maximum of 128 students.

15.2 For B.Sc.(Hons.) each theory period shall be a maximum of 50 minute duration. A practical class will cover a minimum of 3 periods. Each practical or tutorial group will consist of a maximum of 16 students. A general class will have a maximum of 128 students.

15.3 For B.Com.(Pass) & B.Com.(Hons.) each period shall be a maximum of 50 minutes duration. Each tutorial group will consist of a maximum of 16 students. A general class will have a maximum of 128 students.

15.4 The number of periods (Lectures/tutorials/practicals) to be taken for each course is given in the respective tables.

15.5 For a core subject having practicals, the pattern of distribution of teaching will be the same as for a science core subject except that the practical hours may be suitably decreased to accommodate tutorial classes.

#### COURSE STRUCTURE B.A.(PASS)

16. The course structure for B.A.(Pass) is such as to contain foundation course, core courses and Applied Ancillary courses.

17. The total marks for First Examination is 800 and for the Final Examination 600.

18. The candidate will appear in nine papers in First six papers in the Final Examination. Details of number of papers and periods are shown in table-2.

#### 19. FOUNDATION COURSE

a) The students will study two Foundation courses in the first two years. A minimum of two periods per week will be provided for teaching each paper. There will be two papers. Each course will be examined as one

Core-1 : Compulsory Language/Literature course  
Both for First & Final Examination English and M.I.L. will be compulsory and will be treated as two subjects for regulation 6. There will be one paper in each subject carrying 100 marks for each of the examination.

In the First and Final Examinations a student shall have to offer any two of the following core subjects each consisting of two papers and each carrying 100 marks.  
No change of core subject chosen in First Examination is permissible in Final Examination.

Provided that no student shall be allowed to take up Mathematics or any other subject except Anthropology, Geography, Home Science, Education and Psychology in which there is a practical examination if he did not pass in that subject in the Intermediate Examination/Higher Secondary Examination or any other equivalent examination.

Provided further that no student shall be allowed to take up statistics if he has not passed either in Statistics or in Mathematics in the Intermediate Examination/Higher Secondary Examination or any other examination equivalent.

COURSE STRUCTURE : B.A. (HONS.)

The course structure for B.A.(Honours) will contain Foundation core course and ancillary/applied courses.

The total marks for First Examination will be 1000 and that of the Final Examination 800. The candidate will appear in eleven papers in First and eight papers in Final examination. Details are shown in Table 3.

### FOUNDATION COURSES :

A candidate will study two foundation courses in the first two years as per details given in clause 19 supra.

### COMPULSORY LANGUAGE/LITERATURE COURSES.

Core-I (be the Language/Literature course as prescribed for pass students under Regulation 20, Supra.

A Honours student shall take one pass core subject (to be called core-2) and another Honours core subject (to be called core-3) out of the following subjects. In each of the First and Final Examinations there shall be two papers in the pass core subjects each carrying 100 marks. In the Honours core subjects there shall be 4 papers each carrying 100 marks.

COURSE STRUCTURE (B.Sc. (PASS))

The course for B.Sc. (Pass) will comprise of two language courses as Foundation courses, three core courses and one Applied/Ancilliary course.

The total marks for the First Examination is 800 and that for the Final Examination 600 marks. The candidates will appear in 12 papers (9 theory + 3 practical) in the First and 6 papers (3 Theory \* 3 practical) in the Final Examination. Details of no. of papers and periods are given in Table No. 4.

FOUNDATION COURSES

A student shall study two Foundation courses which will be compulsory courses i.e. English & M.I.L. (Oriya, Bangali, Hindi, Urdu or Telugu). However a candidate may offer an alternative paper in English of Higher Standard in lieu M.I.L. enumerated above. Each paper will be of 50 marks & will be taught in one general class & one tutorial class for each subject. No foundation courses will be taught in Final examination.

Core Course

A student shall study three core courses out of the following subjects for the First examination. Each core subject shall consist of two theory papers and one practical paper each carrying 75 and 50 marks respectively. In the Final examination also there shall be three core subjects consisting of one theory paper and one practical paper of 100 marks each.

The subject under core courses are stated below :-

1. Anthropology
2. Botany
3. Chemistry
4. Geology and Mineralogy.
5. Geography
6. Mathematics
7. Physics
8. Psychology
9. Statistics
10. Zoology.

Provided that a candidate shall not be allowed to take up Mathematics or a subject in which there is a practical examination, if he did not pass in that subject in the Intermediate/Higher Secondary Examination (+2 Examination) or any other equivalent examination. A candidate may however, take Anthropology, Psychology, or Geology and Mineralogy, Geography without having passed in that subject in his Intermediate/Higher Secondary Examination.

Provided further that no candidate shall be allowed to take up Statistics if he has not passed either in Statistics or in Mathematics in Intermediate Examination/ the Higher Secondary Examination.

COURSE STRUCTURE B.Sc.(HONS)

The course for B.Sc.(Hons.) will comprise of two language as Foundation courses, three core courses and one Applied/Ancillary course. The total marks for the First Examination is 1000 marks and that for Final Examination, 800 marks.

The candidates will appear in 15 papers (11 Theory + 4 Practical and 8 papers (4 Theory + 4 Practical) in the Final Examination. Details of no. of papers and periods are given in Table No.

Foundation Course : same as clause 31. supra.

A student for Hons. degree shall choose one of the three core courses as his Honours subject. In the First Examination there shall be eight theory papers out of which four will be in Honours subject and will carry 75 marks in each. There shall be four practical papers.

Foundation Course

41. A student shall study two foundation courses for the examination. Each course will carry 50 marks so the Foundation course will be 100 marks in all. No Foundation course will be taught in the Final Year. M.I.L. (One Hindi, Urdu, Telugu or Highest standard English) is a Foundation course and will be called Foundation Course. In addition a student is to offer any one of the following courses as his Foundation Course Paper-II.

1. Evolution of Life.
2. Science in Every day Life.
3. Science and Society
4. Environmental Studies.
5. Resolution of conflict in Society
6. Information and Society
7. Planning and Development
8. Business and Society.

Compulsory English/Economics courses.

42. A student shall have to study English and Economics in First and Final examinations carrying 200 marks in each. There shall be one paper in English and one paper in Economics each carrying 100 marks in the First and the Final examination. This will be called Core-I.

43. Core Courses

A student shall have to study two core subjects one under Core-2 and another under Core-3 each consisting of two papers carrying 100 marks each; for the First B.Com. (Pass) Examination and also for the Final B.Com. (Pass) Examination. The papers for Core Courses to be offered for different examinations as may be prescribed in the Courses of Studies.

44. Applied/Ancillary courses.

A candidate shall study one Applied/Ancillary course carrying 100 marks for the First examination only, choosing any one of the following subjects.

48. Compulsory English/Economics Course :

A student shall have to take English and Economics as compulsory subjects in the First and Final Examinations carrying 200 marks in each subject. There shall be one in English and one paper in economics carrying one hundred in each paper for each examination.

49. Core Courses :

A student shall have to study two Core subjects- one under Core-2 and another under Core-3 in each of the First Examination and the Final Examination. The Core-2 subject will consist of two papers each carrying 100 marks and the Core-3 subject will consist of four papers each carrying 100 marks in both the First and Final B.Com.(Hons.) Examination. The papers under the Core Courses to be offered for different examinations shall be prescribed in the Courses of Studies. Core-3 papers shall be the Honours papers.

50. A student offering Hons. and selecting the Hons. group in the First Examination shall continue to study the same in the Final Examination also. Further, a student who opt "Accountings" Group as Hons. shall not be allowed to opt "Cost Accounting" as one of the pass core subjects.

51. Applied/ Ancillary courses.

A student shall have to choose one applied/ancillary course of 100 marks consisting of one paper in the First Examination out of the subjects, mentioned in clause 44, Supra.

Special provision for successful candidates.

52.1 (a) A candidate who has passed the three year course under these regulations may on payment of prescribed fees be permitted to appear at examinations i.e. First Examination and Final Examination at a time subsequently in any core subject which he has not offered earlier without doing a regular course in a college provided he has secured 30% in each paper of each examination and aggregate in order to pass that subject at that time. If he takes a subject in which a regular course is prescribed, he shall produce a certificate from the Principal of a college under the regulations showing that the candidate had completed a practical course in a laboratory and secured 40% in each of the theory papers and 40% in each of the practical papers in each examination and aggregate in order to pass in that subject.

(b) A candidate who has passed the three year Final Examination (Pass course) of Sambalpur University securing a minimum of 45 per cent aggregate of all core subjects, can appear for the Final Examination in only one of the core subjects.
