

**SAMBALPUR UNIVERSITY REGULATION FOR THE BACHELOR OF ARTS,  
SCIENCE AND COMMERCE EXAMINATIONS  
(THREE-YEAR DEGREE COURSE)**

**(Effective for Students Admitted to First Year of +3 Courses During 2002-2003  
And Afterwards). Amended up to the Academic Council Meeting held on  
05.04.2006**

1.1 The Three Year Degree Course leading to the Bachelor's Degree in Arts/Science/Commerce of Sambalpur University shall be spread over a period of three academic years. A candidate for the Bachelor's degree in Arts/Science/Commerce shall be required to pass the following examinations.

- i. First University Examination.
- ii. Second University Examination.
- iii. Final Third University Examination.

1.2 A candidate shall be eligible to appear the second and final university examination only if he/she registered for the first and second university examination respectively. However, his/her results shall not be published unless he/she has passed the First and Second University Examination respectively.

1.3 A candidate for the Bachelor's Degree in Arts, Science and Commerce Examination shall be required to enroll himself/herself, under these regulations as a student in one of the colleges affiliated to this University.

**ADMISSION TO THE COURSE**

2.1 Any person, who has passed the Higher Secondary Examination of the Council of Higher Secondary Education, Orissa or any other Qualifying Examination recognized by the Academic Council of CHSE, Orissa as equivalent there to may be admitted to the first year of this course provided that a student shall not be admitted into Degree Course in Science unless he has passed the qualifying examination in Science.

2.2 No Student shall ordinarily be admitted into the first year of the course four weeks (including holidays and Sundays) after the date of publication of results of the Annual Higher Secondary Examination of the Council of Higher Secondary Education, Orissa or after the reopening of Summer Vacation which ever is later.

In exceptional cases, the appropriate authority may notify the last date of admission.

2.3 Candidates who, for some valid reasons are unable to take admission within the time prescribed under Regulation 2.2 above, may however be admitted into a College within two weeks (including Holidays and Sundays) from the last date of admission with a late fee as prescribed by the University. The Principal of the College shall intimate the names of such Candidates and their dates of admission and shall remit the late fee collected to the University in one lot within two weeks from the date of such late admission.

2.4 Candidates who have taken late admission, on payment of the late fee, shall have the percentage of lectures counted from the date of such admission.

2.5 Candidates passing the Instant Higher Secondary Examination of the Council of Higher Secondary Education, Orissa may be admitted into a College within two weeks (Including Holidays and Sunday) after the publication of their results provided that candidates may be admitted within one week there after with a late fee as prescribed by the University for each candidates. A candidate so admitted shall have the percentage of Lectures counted from the date of his admission.

2.6 Admission to the Second and Third year course shall be completed within two weeks of the reopening of the colleges without waiting for the publication of results of the First and Second University examination respectively, provided that students may be admitted to the Second or third year, as the case may be, within a further period of two weeks, including Sunday and Holidays, on payment of a late fee as prescribed by University for each student.

2.7 Provided further that students, who could not appear university examination due to shortage of attendance, shall be allowed to take readmission in the same year at the beginning of the immediate subsequent academic session subject to the availability of seats. Preference shall be given to the students who have secured higher marks in the last CHSE or University examination, as the case may be.

2.8 Not notwithstanding anything contained in the preceding regulations, where the syndicate of the University permits increase of seats in any class or gives fresh affiliation to any new subject in any college, the date of issue of such order shall

be deemed as the date of publication of results of the Council of Higher Secondary Education, Orissa for the purpose of admission there to.

2.9 A candidate, whose results of Higher Secondary Examination are published late by the examining authority, may be admitted into the college within two weeks of the publication of his/her results depending on the availability of seats provided that no student can be admitted into +3 First Year Class beyond 31st December of the concerned academic year.

#### **CHANGE OF SUBJECT (S)**

3. A candidate who has been admitted into a college with particular subject(s) or combination of subjects into the first year may be allowed change of subject(s) or combination of subjects by the Principal till thirty days after the last date of admission into first year course as prescribed in the provision of the clause 2 of regulation.

#### **QUALIFICATION FOR ADMISSION TO THE FIRST, SECOND AND FINAL EXAMINATIONS**

4.1 Any registered student of the University may be admitted into the First Examination if he/she has completed in one or more colleges admitted for the purpose of such examination in the subjects which he/she offers a regular course of study for not less than one academic year after passing the Higher Secondary Examination Conducted by the Council of Higher Secondary Education, Orissa or any other examination recognized by CHSE, Orissa and Sambalpur University as equivalent there to, provided he is not otherwise ineligible to appear the said examination.

4.2 Any registered student of university may be admitted to the Second Examination for the Bachelor's Degree in Arts/Science/Commerce if he/she has cleared the first examination in the concerned stream or has appeared the said examination and has thereafter completed a regular course of study for not less than one academic year in the second year course in one or more colleges admitted for the purpose of such examination in the subjects which he/she offers, provided that he/she is not otherwise ineligible for appearing the said examination.

4.3 Any registered student of the University may be admitted to the Final Examination for Bachelor's Degree in Arts/Science/Commerce if he/she has cleared the second examination in the concerned stream or has appeared the said examination and has thereafter completed a regular course of study for not less than one academic year in the third year course in one or more colleges admitted for the purpose of such examination in the subjects which he/she offers, provided that he/she is not otherwise ineligible for appearing the said examination.

4.4 In order to clear an examination (First/Second/Final) a candidate is required to secure 30% marks in a subject and 40% in each practical paper.

#### **PASS MARKS AND CLASSIFICATION OF SUCCESSFUL CANDIDATES**

5.1 Aggregate mark for passing the degree examination shall be the sum total of the aggregate of First, Second and Final Examinations taken together.

5.2.1 Class will be awarded on the Following Basis.

Pass	A Minimum of 30% in each subject and A Minimum of 36% of marks in the aggregate
Pass with Distinction	A Minimum of 30% in each subject and a minimum of 50% of marks in the aggregate.
Pass without Honours	A Minimum of 30% in each subject and a minimum of 36% in aggregate in subjects other than Honours and less than 45% but not less than 36% in honours subject.
Pass without Honours and with Distinction	A Minimum of 30% in each subject and a minimum of 36% in aggregate in subjects other than Honours and a minimum of 50% in aggregate for pass and Honours subject combined.
Second Class Honours	A Minimum of 30% in each subject and a minimum of 36% in aggregate in subject other than Honours and a minimum of 45% marks or more but less than 60% in Honours subject.

Second Class Honours with Distinction

In addition to Second Class Honours a minimum of 50% marks secured in subjects other than Honours in First appearance.

First Class Honours

A Minimum of 30% in each subject and a minimum of 36% in aggregate in subjects other than Honours and a minimum of 60% or more in Honours.

First Class Honours with Distinction

In addition to First Class Honours a minimum of 50% Marks in aggregate in subjects other than Honours in first appearance.

5.2.2 In each of the above examination for subjects having practical a candidate in order to pass must have secured a minimum of 30% of marks in theory paper(s) taken together in a subject and a minimum of 40% marks in practical paper other than Honours subjects provided he/she has secured the minimum aggregate mark.

5.2.3 In each of the above examination for subjects having practical a candidate in order to ensure Honours, must have secured a minimum of 45% of marks in theory paper(s) taken together and a minimum of 45% marks in practical paper(s) taken together in Honours subject.

5.3.a If a candidate is marked absent in any sitting(s) of an examination such a candidate shall have to reappear in that paper(s) subject(s) in order that his/her results are declared provided further that the higher marks in such theory paper shall be taken into consideration, incase of students remaining absent in any paper the marks secured in the earlier examination in that paper will be considered.

5.3.b A Candidate failing to secure a minimum of 30% in pass subject and /or a minimum of 40% in each practical paper either in the First Second or Final examination of this University may be allowed to appear in those subjects in not

more than two chances (examination immediately following that examination for which he was first registered to clear the back paper(s) on payment of prescribed fees provided that a candidate who has already passed the practical of any subject need not appear the same again. However if a candidate who has not cleared an examination may at his option appear in all the papers of that examination under the following conditions.

- (i). Marks secured by the candidates in that examination earlier stand cancelled.
- (ii). After exercising the option to appear in all papers of an examination, if a candidate fails to clear that examination he/she will be required to appear in all the papers of that examination in a subsequent chance, within 5 years of first registration to First Degree Examination.

5.3 c If a candidate has appeared in back papers in the first chance and in all the papers in the second chance and also has failed such a candidate can appear at that examination (in all papers) under new course only within 5 years of 1<sup>st</sup> registration to First Degree examination.

5.3.d If the candidate fails to secure the pass marks in the aggregate (under regulation 5.2) he/she may reappear in one or more subjects/paper(s) of his choice from either the First, Second or Final Examination to make up the deficiency. This chance shall be available to a candidate in maximum two subsequent chances (Examinations) only following the Final Examination in which he/she was first registered but within 5 years of 1<sup>st</sup> registration to First Degree Examination.

e (i) Candidates who have been duly admitted to B.A./B.Sc./B. Com. (Honours) (3 year degree course) examination of the Sambalpur University and have obtained only a Second Class (Honours) or passed without Honours can reappear at any examination(s) for the Honours papers only of his/her choice to improve their results within two subsequent chances (Examination), on application submitted through the Principal of a College affiliated to Sambalpur University in the subject up to the Honours level. The higher of the marks in each paper shall be taken into consideration for determining their results and divisions. However,

distinctions if earned by the candidate shall not be effected by improvements examination under the clause.

(ii). Provided that a candidate shall be allowed to improve his performance in theory papers only and only once after passing the B.A./B.Sc./B.Com (Three Years Degree Course) Examination of Sambalpur University.

(iii). A candidate who wishes to improve performance in Honours shall be required to fill in application forms and pay the requisite fees accordingly.

(iv). Collegiate candidates taking this advantage be treated as regular candidates and will be examined on the basis of current syllabus.

(v). The expression "Subject" shall include all the papers comprised in the subject.

(F). Provided further that in no case a candidate shall be allowed to appear any examination after 5 years of first registration to First University Examination.

#### **MODE OF EXAMINATION AND DURATION OF PAPER**

6.1 The Examination in Arts/Science/Commerce shall be conducted by means of written papers.

6.2 There shall be a practical examination in all subjects in which it IS prescribed in syllabus.

6.3 The duration of examination for each theory paper carrying 50 marks shall be two hours, and for each theory paper carrying 75 or 100 marks, it shall be 3 hours.

For practical examinations in +3 Arts/Science/Commerce (Pass and Honours) the paper carrying 50 marks shall be of 4 hours duration and paper having 75/100 marks shall be of 6 hours duration. The course contain of the papers shall be designed accordingly by respective Board of Studies.

6.4 The laboratory notebook or the fields work notebook of each candidate who offers a subject in which there is practical examination, shall be inspected by the Examiners who shall take those into consideration which determines the results of the practical examination. Each experiment in every note book shall contain the date of the experiment, signature of the student and the initial of the teacher with date under whom the experiment was performed.

6.5 The question paper for the University Examination in Arts/Science/Commerce shall contain alternative questions on the courses of study prescribed

for the preceding year where such courses of study have since been altered or amended.

## **7. MARK DISTRIBUTION**

The mark distribution in B.A./B.Sc/B.Com (Pass and Honours) Examination shall be as follows.

8.2 A pass student shall offer one pass subject 400 marks in addition to compulsory and Elective Papers. Each student shall offer two elective subjects. Each elective subject shall consist of two papers each carrying 100 mark. Subject with practical component shall have 75% theory and 25% practical.

9.2 A candidate in B.A. (Honours) shall offer a Honours Subject carrying 800 marks and two elective subjects besides compulsory subjects. Each elective subject shall consist of two papers each carrying 100 mark. Subject with practical component shall have 75% theory and 25% practical.

10. A candidate (Honours or Pass) shall choose two elective subjects, each carrying 200 marks (without any practical component) from among the following subjects or other subjects that may be decided by the University according to suitability.

Indian Polity, Indian Economy, Indian Geography, landmark in History, Science and Technology, Mathematics, statistics, Home Science, Psychology, Education, Archaeology, & Museology, Philosophy, Computer Application, English, Oriya, Sanskrit and Sociology provided that a student (Honours or Pass) offering Political Science, Economics, History, geography, Mathematics, Statistics, Home Science Psychology, Education, Archaeology and Museology, Philosophy, Computer Application, English, Oriya, Sanskrit and Sociology as one or more Pass or Honours subject Is) shall not be allowed to take Indian Polity, Indian Economics, landmarks in Indian History, Indian Geography, Mathematics, Statistics, Home Science, Psychology, Education, Archaeology and Museology, Philosophy, Computer Application, English, Oriya, Sanskrit and Sociology

respectively as his/her elective paper (s). A candidate may choose Functional English as an elective paper for Arts student provided he/she has not offered English as a Pass, Honours as optional subject.

11.2 A candidate shall choose in B.Sc. (Pass) shall two pass subjects each carrying 400 marks besides compulsory and elective papers. Subject with practical shall have 25% practical and 75% theory. There shall be two electives, one major carrying 200 marks with two papers of 100 mark each and one minor carrying 100 marks.

12.2 A B.Sc. (Honours) student shall choose an honours subject carrying 800 marks, one pass subject carrying 400 marks, one minor elective carrying 100 marks and one major elective of 200 marks consisting of two papers each carrying 100 mark besides compulsory papers. Subject (s) with practical shall carry 75% theory and 25% practical.

13.1 Minor Elective Paper: In Science (both Honours and Pass), a student with Life Science (Botany/Zoology etc.) as pass or Honours shall take one Minor Elective Paper on "Mathematics and Statistics for Biology students" carrying 100 marks where as the other students (of Physical Sciences) shall take "Biology for Physical Sciences students" as minor Elective carrying 100 marks.

13.2 A B.Sc. (Pass) student shall choose one subject as Major Elective from among the following subjects or other subject (s), to be decided by the University according to suitability and availability of subjects in the college, carrying 200 marks with two papers of 100 mark each (without any practical component).

Biotechnology (To be taught by Biology Teachers), Non-conventional Energy Resources (To be taught by Physics and Biology Teachers), Remote Sensing (To be taught by Physics and Geology Teachers) Polymer Sciences (To be taught by Chemistry Teacher) and Disaster Management (To be taught by all group of Science Teacher), Industrial Chemistry (To be taught by Chemistry Teacher), conservation and Management of Natural Resources (To be taught by Physics and Biology Teachers), Material Sciences (To be taught by Physics and Chemistry Teacher), Pisciculture (To be taught by Biology Teachers), Sustainable Agriculture Practices (To be taught by Biology Teachers), computer Application (To be taught by teacher in Physics and Mathematics where computer science teachers are available), Life Science (Covering Botany, Zoology, Microbiology, Biochemistry, Environmental Biology, Genetics etc. to be taught by Biology Teachers). Provided that a student (Honours or Pass) any of the subject like Life Sciences, Physics, Chemistry, Mathematics, Statistics, Anthropology, Geography, Psychology, Environmental Science, Information Technology as Honours or Pass shall not be allowed to offer corresponding subject as a major elective paper.

13.3 The following elective courses may be taught by the subjects teacher as mentioned against each:

14.1 In B.A./B.Sc./B.Com Pass subject (s) with practical, and carrying 400 marks following distribution of marks shall be made.

Paper-I =75 (Theory), Paper-II= 75 (Theory), Paper-III=50 (Practical), Paper-IV=75 (Theory), Paper-V (Theory) =75 and Paper VI (Practical)=50

And the distribution of papers be made accordingly so as to confirm the year-wise mark distribution as envisaged in the regulation 7.1.

14.2 Elective subjects shall not carry any practical component.

14.3 A candidate shall be allowed to offer anyone of the following M.I.L Oriya; Hindi, Bengali, Telugu, and Urdu, provided that a candidate shall be allowed to offer Alternative English in lieu of M.I.L.

## ATTENDANCE

16.1 A Candidate shall be required to attend 75% of the lectures, tutorial and practical classes, taken separately, in each subject during each academic year and condonation in exceptional cases may be granted by the college to the extent of 15%.

16.2 The Syndicate may grant further condonation of shortage in attendance to the extend of 10% in respect of candidates who represented the University or State on deputation for inter University or National Camp, competition games or sports, to be recorded in writing.

16.3 A candidate may be permitted to take up one the M.I.L. as specified under clauses 14.3 of these regulation without the requirement of attendance at lectures, if a college in which he or she is admitted is not affiliated in that subject.

## APPLICATION FOR ADMISSION TO EXAMINATION

17.1 Candidate for admission to the First/Second/Final examination in Arts, Science, or Commerce shall specify the subjects/papers as the case may be in which he desires to be examined for the Pass and Honours examination in the form of application prescribed for the purpose.

17.2 The application submitted by every candidate for admission to any examination, other than the back subject (s) papers in Arts/ Science/Commerce

shall contain a certificate of the candidate (s) (i) good conduct, (ii) diligent study [iii) having maintained the required percentage of attendance in each class or having obtained condonation for the shortage or attendance if it is within the admissible range, and (iv) having satisfactorily passed the periodical and test examination conducted by the college concerned, duly signed by the Principal or in any teacher of the college authorized for the purpose by the Principal of the college. Failure to earn any of the aforesaid certificates from the Principal of the college will disqualify the candidate for being admitted to the examination till he earns the same.

Provided that a candidate seeking admission to an examination under Regulation 5.3 [clearance of back subject papers) need not obtain attendance certificate. He/She should however, obtain other certificates as required.

17.3 The fees payable for registration/ Admission to any examination, under this regulation shall be as prescribed from time to time.

17.4 If a candidate has paid full fees for all the subjects, in any examination but remained absent in all the subjects, he/she shall be required to pay the full prescribed fees if he appears at the same examination again in the subsequent years (s).

#### **DROPPING OF HONOURS COURSE**

18. A candidate taking Honours, Course initially in a subject may choose in writing to drop the Honours course and adopt the pass course in the same subject at the time of submitting his application for the First Examination or earlier and he/she then appear subsequent examination.

#### **19. MIGRATION**

Any candidate who has been registered as such in any other University of the State will be permitted to migrate to this University to register either for the First, Second, or the Final Examination of this University. In such case, the marks obtained by him/her in the First or Second Examination, as the case may be, of the other University will be taken as the marks obtained by him/her for the result as per the provision of the regulation, Act and statute.

## **DURATION OF PERIOD AND GROUPS**

20. For B.A./B.Sc./B.Com (Pass and Honours), each period shall be of maximum of 50 minutes duration. Each practical class may cover a minimum of 3 periods. Each tutorial/practical group will consist of a maximum of 16 students. A general group class will have a maximum of 128 students. Each theory papers of 100 marks shall be taught in 3 periods of 75 marks in two period and 50 marks in one period per week. The duration of each theory paper shall be 45/50 minutes.

### **Subjects B.A. (Pass)**

21.1 A B.A. (Pass) student shall have to offer anyone of the following pass subjects carrying 400 marks each, subject to other conditions mentioned in the regulation.

21.2 No Student shall be allowed to take Statistics if he has not passed either in Statistics or in Mathematics in the Higher Secondary Education/Intermediate Examination or any other examination equivalent thereto.

21.3 A Student shall be allowed to take Archeology and Museology if he/ she has completed 10+2 with Science stream or had one more of the following subject(s)/paper(s).

Sanskrit, History, Archeology, and Museology, English and Regional Language, Geology, geography, Computer Science, Political Science, Anthropology.

The subject combination +3 level is limited to the subject mentioned above unless otherwise it is modified by the Academic Council.

22.2 Provided that no student shall be allowed to take Mathematics or any other subject in which there is a practical examination, if he/she did not pass in that subject in the Intermediate Higher Secondary Examination or any other examination equivalent thereto. A student may, however take Anthropology, Education, Psychology, or Geology, Geography, Home Science without having passed in that subject in the Intermediate/Higher Secondary Examination or any other Examination equivalent thereto.

22.3 Provided further that no student shall be allowed to take Statistics if he has not passed either in Statistics or in Mathematics in the Intermediate Examination/Higher Secondary Examination or any other examination equivalent thereto.

### **Subjects B.Sc. (Pass)**

23.1 A B.Sc. (Pass) student shall choose any two of the following pass subjects, each carrying 400 marks depending on the availability of the subject in the college and convenience.

23.2 A candidate shall not be allowed to take mathematics or a subject in which there is practical examination, if he did not pass in that subject in the Intermediate/Higher Secondary Examination (+2 Examination) or any other equivalent examination. A candidate may however, take Anthropology, Computer Science, Computer Application, Environmental Science, Food Science and Quality Control, Industrial Fish and Fisheries, Sericulture, Psychology, Geology and Mineralogy, Geography without having passed that subject in his Higher Secondary/Intermediate Examination. Subject to availability of subjects in the college.

23.3 No candidate shall be allowed to take Statistics if he has not passed either in Statistics or in Mathematics in Intermediate Examination/Higher Secondary Examination or any other equivalent examination.

23.4 No student shall be allowed to take Sericulture, if he/she has not passed +2/ Higher Secondary Examination in Science with Physics, Chemistry and Biology and a student shall be allowed to take Sericulture at +3 level with zoology as other subjects.

23.5 No student shall be allowed to take Industrial Chemistry if he/she has not passed +2/Higher Secondary Examination in Science with Chemistry as one of the optional subjects and a student will be allowed to take Industrial Chemistry at +3 level with Chemistry as other subject.

23.6 No student shall be allowed to take Food Science and Quality Control if he/she has not passed +2/Higher Secondary Examination with Biology as one of the optional subjects and a student shall be allowed to take Food Science and Quality control at +3 level with Chemistry as the other subjects.

23.7 The provision on eligibility criteria and subject combination for Industrial chemistry above shall also be applicable to Textile Science. However no student shall be allowed to take more than one subject either as pass or honours from among the subjects like Industrial Chemistry and Textile Science.

23.8 No student shall be allowed to take Computer Science or Computer Application if he/she has not passed +2/Higher Secondary Examination with Mathematics as the other subjects.

### **Subjects B.Sc. (Honours)**

24.1 A B.Sc. (Honours) student shall choose anyone of the following subjects as Honours or any other subject depending on its availability in the college and prescribed by the Academic Council.

1. Botany	2. Chemistry
3. Computer Science and Data Processing	4. Electronics
5. Environmental Science	6. Geology
7. Mathematics	8. Physics

24.2 Provisions of clause 23.2 to 23.8 shall also be made applicable where required to a B.Sc. Honours candidate.

### **24.3 The combination of Honours and Pass subjects**

A candidate is free to choose any two subjects, one as Honours from 24.1 and other as pass from 23.1 depending on the availability of the subject in the respective college and convenience.

## **PUBLICATION OF RESULTS**

25.1 The results of the 3 years B.A./B.Sc./B.Com Degree Examination and the classes to be awarded shall be determined on the basis of the combined results of First, Second, and Final Examination taken together while notifying the results of candidates appearing in back paper and improvements after the concerned Final Examination the date of passing examination will be the date in which the candidate has cleared/improved all examination for that degree.

25.2

- A. As soon as possible preferably within 45 days after the completion of Final Examination (Theory Paper) the Syndicate shall publish a list of successful candidates based on the marks of First, Second and Final Examination.
- B. There shall be separate lists for candidates of Pass and Honours in each stream of Arts, Science, and Commerce.
- C. The list of those candidates who pass in the 15t Class in the Honours course of a particular subject shall be arranged in order of merit, and the list of all other successful candidates of the Honours Course of that subject shall be arranged alphabetically and college wise. In case of a successful Honours Candidates obtaining Distinction it shall be mentioned against his/her name in the list.
- D. Candidates who pass in their 151 appearances and in one session will be placed above those who pass with Back paper Clearance in the merit list.
- E. The list of candidates who pass the Pass course shall be arranged college wise according to the roll numbers. In case a candidate has obtained Distinction, it shall be mentioned against his/her name.

25.3 Each successful candidate at the Final Examination of the 3 years Degree Course shall receive a Diploma in prescribed form signed by the Vice-Chancellor.

#### **SPECIAL PROVISION FOR SUCCESSFUL CANDIDATES**

26.1 A candidate who has passed 3 years Degree Final B.A.,B.Sc.,B.Com (Pass) Examination under Sambalpur University securing a minimum of 45% marks in the aggregate can appear in Honours Examination in only one of the pass subjects offered by him/her in pass course, subject to the provision of 5.3.f, provided that he/she has secured a minimum of 45% in aggregate in that pass paper.

26.2 In subjects where practical courses are offered, a candidate shall undergo practical training for a period of six months and submit a certificate at the time of submitting the final application form to that effect from the Principal/ H.O.D. of a college where such subject is taught up to Honours level.

26.3 A candidate improving his/ her performance under this provision will be examined on the basis of syllabus prevailing at that time of his / her first registration to first degree examination.
