The suggestions of the reviewers will be taken into consideration and the final draft will be sent to the Universities for their views, followed by approval in their Board of Studies and Academic Council. An honorarium of Rs.4,000/- (Rupees Four thousand only) towards each review will be paid which will be met out of RUSA preparatory fund.

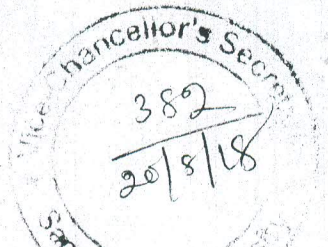
