Other Eligibility Conditions:

- (a) The candidate must be a citizen of India.
- (b) The candidate should be able to speak, read and write Odia fluently and must have passed at least an examination in Odia language equivalent to M.E. School standard.
- (c) Probation period for Librarian positions is 02 (two) year from the date of joining into the post.
- (d) A candidate, who has more than one spouse living will not be eligible for appointment unless the state government has exempted his/her case from operation of this limitation for any good and sufficient reasons.
