## **Eligibility, Qualification and Monthly Remuneration of Assistant Professor**

1. **Fixed Remuneration:** Rs.21,600/- (Rupees Twenty One Thousand Six Hundred) only  
No D.A. or other allowances will be paid.

2. **Eligibility:**

- (a) A Master's Degree with at least 55% marks (or an equivalent grade on a point-scale, wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (b) Besides fulfilling the above qualification, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or similar tests accredited by the UGC, like SLET/SET.

Or

Candidates who are or have been awarded Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET.

Provided, the candidates registered for the Ph.D. Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor subject to the fulfilment of the following conditions:-


1. The Ph.D. degree of the candidate has been awarded in a regular mode.
  2. The Ph.D. thesis has been evaluated by at least two external examiners.
  3. An open Ph.D. viva voce of the candidates has been conducted.
  4. The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a referred journal.
  5. The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/supported by the UGC/ICSSR or any similar agency.
- The fulfilment of these conditions is to be certified by the Registrar of the Dean (Academic Affairs) of the University concerned.

3. **DOCUMENTS TO BE SUBMITTED AT THE TIME OF INTERVIEW**

- a. Application in plain paper
- b. Bio-data of the candidate
- c. Self attested copies of the certificates and mark sheets of all examinations passed.
- d. Teaching experience certificates from appropriate authority.
- e. API Score Card for the post of Associate Professor.
- f. Two passport size colour photographs.
- g. A Demand Draft of Rs.500/- payable in favour of Director, DDCE, Sambalpur University, payable at State Bank of India, Jyoti Vihar.

#### 4. OTHER CONDITIONS

- a. Candidates are required to attend the Interview, at their own expenses. No TA/DA etc. Shall be paid for the purpose.
- b. Candidates are required to produce their Original Certificates and Mark Sheets/Testimonials/ Documents for verification at the time of interview.
- c. Posts are purely temporary and selected candidates shall be appointed for 11 Months.
- d. The University reserves the right to cancel the entire process of interview/selection process without assigning any reason thereof.
