- F) Two sets of hard copy of alphabetical list duly certified and signed by the Principal with seal along with application forms and the receipt obtained on submission of data from the University Computer Centre must be submitted to E.G.-V Section by **Speed Post** to **The Controller of Examinations, Sambalpur University, Jyoti Vihar, Burla, Sambalpur, Odisha – 768019**. The application Forms must reaches the University office by **Dt. 11.3.2022**.

- Accounts Statement in duplicate.
