V Semester : SEC – III – will be as per the model syllabus of following subject for Arts (Pass).

Home Science - Home Bases catering

Economics - Computer Application

Hindi - Drusya-Sabya Madhayna Lekha

Geography - Disaster Management

Pol.Sc. - Legislative practice & procedure

Philosophy - Critical Thinking

Sociology - Political security

The subjects of Arts(Pass) that do not offer any SEC in their respective model syllabus be taught the SEC-III of the previous syllabus i.e. (University Syllabus).


- (1) The subjects where option has been given to student to opt Project/Dissertation or paper, in that case project/dissertation is compulsory to all.


