The Public Liability Insurance Act, 1991 regulate the Industry; which are hazardous in operation or in activities. The primary objective of the Public Liability Insurance Act 1991 is to provide compensation to the victim of accident occurred due to operation/handling of hazardous material in Industry. apply to all owners engaged in This Act operation/handling of hazardous substance. General public who are in the vicinity of hazardous industrial area and become a victim to industrial disaster are protected under this Act. Generally, the weaker section of the society is victim of the industrial disaster; that caused death/ permanent injury of human being or loss in the property either public property or private property. So, this act provides immediate relief to the victim of industrial disaster.
