ADDENDUM TO AGREEMENT BY AND BETWEEN

CENTRE FOR DISTANCE AND ONLINE EDUCATION, SAMBALPUR UNIVERSITY

TEAMLEASE EDTECH LIMITED, MUMBAI

THIS ADDENDUM made and entered into this 18th January 2022, by and between:

(i) CENTRE FOR DISTANCE AND ONLINE EDUCATION (CDOE), SAMBALPUR UNIVERSITY having its headquarters at Sambalpur University, Jyoti Vihar, Burla, Sambalpur, Odisha- 768019, herein after called the "University" of the FIRST PART

AND

(ii) **TEAMLEASE EDTECH LTD.**, having its registered office at 903, Western Edge II, Western Express Highway, Borivali (E), Mumbai - 400066 and possessing ROC registration number U80301MH2010PTC211390 hereinafter called "Service Provider" of the OTHER PART provides for the following amendments in the original agreement signed between them on 6th January 2022.

Where as

(a) The University and the Service Provider have entered into a service agreement for "Online Academic Support, Admission and Examination Services; Content Development and Digitization of Self Learning Materials for Online Programs"

- (b) The University is a UGC approved 'State University' that has endeavored to launch programs that will create employable manpower, which is of crucial importance to the economy of the state and the country. The University is committed to make learning more effective by application of Apprenticeship committed Learning in its Degree Programs. The Service Provider is in the Embedded Learning in its Degree Programs. The Service Provider is in the business of developing technology and the digital course content for several Courses as well as facilitating Apprenticeship Embedded Programs that it offers to multiple universities and educational institutions.
- (c) Through this addendum the University, with the help of the Service Provider, agrees to offer Apprenticeship Embedded BBA Program as in Table-1. The Apprenticeship Embedded BBA Degree Program will be offered from Academic session 2021–2022. The number of the program offered may, however, be modified by mutual consent.
- (d) Through this addendum the roles and responsibility of the Service Provider has been expanded to providing value added services related to apprenticeship and employability to the enrolled learners. Out of the total number of students enrolled in this Apprenticeship Embedded BBA Degree Program, a minimum of 15 % students will be provided Apprenticeship inside Odisha and rest students will do Apprenticeship outside the state.
- (e) The Service Provider will charge the value-added services fees for facilitating Apprenticeship and Employability services as detailed under the head value Added Services in Table 1. It is agreed that the fee for the value-added services shall be paid to the Service Provider for rendering additional value services to apprenticeship and employability. Further to this, the Service Providers share shall be 50 % of the Course fees being paid by the student. The other terms of fee sharing between the University and the Service Provider remain unchanged, whereas the said service of Apprenticeship Embedded Degree Program related services can be terminated within 90 (ninety) days if the Service Provider is unable to satisfy anywhere between Admissions to the said program and supporting students for employability.
- (f) The fee structure of the Apprenticeship Embedded Degree Program is detailed in Table -1. The fee structure may, however, be revised in future with mutual consent.
- (g) The University and the Service Provider agreed to make these amendments with mutual consent and except and otherwise provided herein all terms and conditions of the agreement shall remain unchanged.
