#### **COURSE SCHEME**

# **DETAILS OF THE COURSE CURRICULUM**

#### FIRST SEMESTER

# Paper-I: (Course-611) Social Work, Social Policy and Methods of Intervention

#### Introduction

This course aims at introducing the learners to a critical inquiry into the history of ideologies of social change and professional social work.

# **Objectives**

- Understand the values of social work and consciously apply those in practice
- Develop skills to understand contemporary reality in its historical context
- Understand self as a part of own environment and explore own assumptions, ideas and values to develop sensitivity to marginalization of vulnerable groups.

#### **Expected Outcome**

The students would learn about the historical evolution of professional social work, contemporary ideologies and its relation to social policy.

- **Unit I:** Social work: Definition, objectives, principles, philosophies and scope, Social action: Meaning & Process, Social security, Evolution of social work in India and abroad.
- **Unit-II:** Social Policy: Concepts, Social Policy, Economic Policy, Social Policy in India: Sources of Policy-Indian Constitution, Fundamental Rights and Directive Principles of State Policy.
- **Unit-III:** Policy Formulation Process, Role of Various actors in policy formulation -International Organizations (UN, W.T.O, World Bank), Pressure Groups, Advocacy Networks, Academic and Research Organization, Industry and Market Forces, Social Workers.
- **Unit-IV:** Social Work Intervention: Understanding individuals, groups and communities; Working with individuals, groups and communities. Intervention processes of Social Case work, Social Group work and community organisation.

# **Elective-1: Human Resource Development**

The course introduces the concepts of HRD and appraisal. It intends to orient the candidates to understand the HR dimensions in organizational set up.

### **Objectives**

- Acquire human skills to excel the performance at the individual and organizational level
- To acquaint trainee about the different methods of performance appraisal.

# **Expected Outcome**

The students would learn about HRD and OB practices and strategies and would acquire human skills to excel the performance at the individual and organizational level

- Unit I: Concept and Meaning: Difference between HRM and Personnel Management, Fundamentals of HRM and Human Resource Development, Human Resource Planning, Career and Succession Planning, Human Resource Policies
- Unit II: Human Resource Planning and Recruitment: Manpower Planning, Job Analysis, Job Description, Job evaluation, Recruitment and Selection; Psychological Testing, Interview, Placements, Induction, Promotion, Demotion, Transfers, Separation, Absenteeism and Turnover.

Unit III: Human Resource Development and Appraisal: Organisational Culture, Training Programme: Employees Training and Development, Performance Appraisal, 360 Degree Performance, Potential Appraisals

Unit IV: Strengthening the Human Resource: Collective Bargaining, Labour Welfare, Wage and Salary Administration, Incentives, Wage and Non Wage Incentives. Retirement, Separation, Termination, Golden Handshake, Industrial Discipline and Disciplinary Action, Grievances Handling.

# Elective-3: Medical and Psychiatric Social Work

#### Introduction

This course extends and elaborates the generalist Social Work approach to a special field practice. The purpose of this course is to introduce the students to the social worker's role in a variety of health care settings. Students will gain knowledge about health and disease, policies, programs and service delivery systems relevant to the health practice field and their roles and responsibilities.

### **Objectives**

- Introduce and understand the various roles and functions of the social worker in health care settings.
- Integrate knowledge of the meaning of illness, disability and loss for patients and families with general clinical understanding of human behaviour and the life cycle to form a base of social work practice in health care settings.
- Understanding psychotherapy and psycho-diagnostic techniques.

# **Expected Outcome**

The students would develop an understanding of holistic health care needs relating to diverse cultural setting and understand about medical and psychiatric social work.

- Unit-I: Concept of Health and Disease: Dimensions, Determinants and Indicators of Health, Communicable diseases and Non Communicable diseases. Health Care Delivery System in India, Voluntary Health Agencies, National Health programs and policies; Functions of medical social worker.
- **Unit-II:** Psychiatric Social Work: Basic concepts and theoretical framework, historical development, major approaches in psychiatric social work; Social diagnosis and therapeutic Models in Psychiatric
- Unit-III: Psychiatric Social Work in Different Settings: Family service agencies, child welfare agencies, school settings, correctional institutions, general hospital settings, deaddiction centres; Mental Health Act, 1987, Rehabilitation Council of India Act, 1992; The Persons with Disabilities Act, 1995.
- Unit-IV: Psychotherapy and Psycho-diagnostics: Catharsis, hypnosis, techniques of evaluation, cognitive functions and their measurement, tests of intelligence and intellectual impairment, personality tests, tests of achievement and aptitude. Social Pathology Crime and delinquency, suicide, addictive behaviour, social aggression with special reference to Indian contexts.

- Understand the need for scientific approach to human inquiry in comparison to the native or common sense approach.
- Conduct simple interviews including use of observation skills.
- Prepare simple tools for data collection, code and fill in the coding sheets.
- Develop research report writing skills.
- Develop an understanding of simple statistical tools, and learn to use these

# **Expected outcome**

The students would learn the advance of scientific approaches to human inquiry and the report writing skills.

Unit-I: Application of statistical concept/ procedure, Data Diagrammatic representation of data, probability, Measure of central tendency, Measures of dispersion, Normal distribution: Simple correlation, regression analysis, sampling: Simple random sampling.

**Unit-II:** Testing of Hypothesis, Tests X2 (Chi-square), T- and F-\_tests, Analysis of variance, one way Analysis of Variance, Two way Analysis of Variance, Writing of research reports

**Unit-III:** Functional unit of a computer, window operating system, managing files and folder, word editing and formatting, working with tables, creating and printing a presentation, producing a slide show, editing and formatting worksheet, performing basic calculation, working with chart, using the internet and the world wide web.

**Unit-IV:** Learning software package specific to social sciences.
