All the documents should be enclosed with a sealed envelope which must be superscripted as **"Comprehensive AMC of Phase-I & Phase-II Networking including Servers and Other Peripherals installed in Sambalpur University"** with **Quotation No. & Date**. The offer received by the University on or before the scheduled date and time shall only be entertained.


(Terms and Conditions)

Eligibility criteria for the bidder & General Terms and condition for bidding:

1. The bidder must be a registered company/firm under the Indian Companies Act/Odisha Commercial Act.
2. The bidder should have similar networking, hardware etc. services experience and must submit details of all the works executed.
3. The bidder must have GST Registration Certificate, Latest GST return certificate, PAN and latest **Income tax Return Certificate**, etc.
4. The bidder has to submit an EMD of Rs. 30,000/- (Rupees Thirty Thousand) only which is refundable, in shape of demand draft drawn from any Nationalized Bank in favor of Comptroller of Finance, Sambalpur University, payable at SBI, Jyoti Vihar, Burla, with the bid.
5. The bidder must have adequate infrastructure and personnel to carry out the assignment & must be agree to replace all spares/ defectives of same make & model **(An Undertaking/Declaration has to be submitted by the bidder)**.
6. **Bidders quoted for all the items mentioned in the tender will only be considered.**
7. **The Financial Bid must be given as per the format given in Annexure-A and the Comparative Statement will be prepared taking into consideration the grand total amount. Further, the bidder is required to submit the item wise details of financial statement as per Annexure-B.**
8. The bidder should be capable of giving proper service support to our University.
9. Bidders, who have not satisfactory completed any of the earlier contracts with our University, will not be eligible for participation in this tender.
10. The companies or vendors, bidding for the above tender, should have not black listed by any of Government Authority or Public Sector Undertakings (PSUs).
11. The bidder must submit the Eligibility Bid and the Financial Bid **separately**.
12. The bidder will be allowed to bid in Indian Rupees only.
13. The phase-I Networking was developed in January, 2007 with cost of Rs.62,45,016/- (Approx.), which is in operational condition.
14. The phase-II Networking was developed in July, 2009 with cost of Rs.1,11,09,153/- (Approx.), which is in operational condition.
15. The bidder has to maintain and monitor the entire Phase-I & Phase-II networking & hardware items **(Annexure-B)** under e-Governance plan with no down time. **The items are installed in the areas of Hostels, Departments, Offices, Residential Quarters and Health Centre covering the entire University Campus.**
16. In case of any down time beyond 1 Hour, **Rs. 2000/-** (Rupees Two thousand only) per hour of fraction there of shall be charged demurrage by the University and will deducted from the final settlement of the bill.
17. The University will not entertain any joint bidding (by two or more vendors).
18. The bidder has to take enough care to check miss utilization /improper /unauthorized use of the networking equipments.
19. **The vendor must include deputation of two qualified (B-Tech.) and technically certified dedicated site engineers having minimum 5 to 6 yrs of experience of similar work.**
20. **The Bidder must be deposit Photo copies of all the technical qualification with work experience certificates of both engineers separately in tender document.**

21. During this Comprehensive AMC Vendor will provide All Spares like Nortel Switches with its SFP Modules, Cisco Switches with its SFP Modules, Media Convertors with adopters and fiber splicing included.
22. It is mandatory to replace all defectives with same make & model only during this AMC period vendor.
23. After finalization of the bid, the bidder has to enter into an agreement with Sambalpur University. Dispute if any will be subject to legal jurisdiction of Odisha only.
24. The Dy. Director, e-Governance Nodal Centre, Sambalpur University will be the single point contact for all purposes.
25. The bidder has to have prior permission of the University before making any alteration to the existing network, should there be a need for such alteration.
26. The bidder must quote the AMC price for a period one year, two years and three years as per Annexure-A.
27. The terms of payment shall be made half yearly basis in advance which will be completed in two installments.
28. The bidder must personally check the equipment and facility, make, model etc. before applying for the same and accordingly, prepare the documents.
29. Apart from the above, the vendor may quote for any other additional items or facilities in a separate sheet with justification and cost.
30. The University shall have the rights to alter, modify or delete any term and condition before the agreement is signed.
31. The authority reserves the right to reject any or all quotations or accept any without assigning any reason thereof.

The quotations complete in all respect should only be considered, so the vendors are required to visit the University Campus for their convenience before submission of their quotations. The bids will be opened in presence of the vendors which will be intimated by email. The vendors should also furnish their local address, email, contact nos. etc. For more details please contact to the **Director, e-Governance Nodal Centre, Sambalpur University during 11:00 AM to 05:00 PM in working day only.**
