

**TERMS AND CONDITIONS FOR COMPREHENSIVE AMC OF WI-FI NETWORK INSTALLED IN SAMBALPUR UNIVERSITY**

(Ref. No. 75 /17-18/e-Gov. dated 06/03/2018 )

**I. Eligibility criteria for the bidder:**


1. The bidder must be a registered company/firm under the Indian Companies Act/Odisha Commercial Act.
2. The bidder must submit details of all the works executed.
3. The bidder must have an adequate infrastructure and personnel to carry out the assignment (An Undertaking has to be submitted by the bidder).
4. The bidder must submit its GST documents along with valid PAN & other registration certificates.

**II. Important Terms and condition for bidding :**

1. Bidders quoted for all the items mentioned in the tender will only be considered.
2. The Financial Bid must be given as per the format given in Annexure-A, further item wise financial statement as per Annexure-B should also be attached with this and the Comparative Statement will be prepared taking into consideration the grand total amount.
3. The bidder should be capable of giving proper service support to our University.
4. Bidders, who have not satisfactory completed any of the earlier contracts with our University, will not be eligible for participation in this tender.
5. The companies or vendors, bidding for the above tender, should have not black listed by any of Government Authority or Public Sector Undertakings (PSUs).
6. The vendor should have service centre/support centre in the **Western Part of Odisha, preferable in Sambalpur (Address Proof must be attached)**.
7. The bidder must submit the Eligibility Bid and the Financial Bid **separately** and Financial Bid will be opened for eligible bidders only.
8. The bidder will be allowed to bid in Indian Rupees only.
9. The Wi-Fi installation in University Campus was developed in 2016 with cost of Rs.29,34,322/- which is in operational condition.
10. The vendors are requested to visit the University campus for their convenience and information.
11. The bidder has to submit an EMD of Rs. 10,000/- (Rupees Ten Thousand) only which is refundable, in shape of demand draft in favor of Comptroller of Finance, Sambalpur University, payable at SBI, Jyoti Vihar, Burla, with the bid.
12. The bidder has to maintain and monitor the entire Wi-Fi network including Switches and other peripherals (Annexure-A) under e-Governance plan with no down time.
13. In case of any down time beyond 1 Hour, Rs. 1500/- per hour of fraction thereof shall be charged demurrage by the University and will deducted from the final settlement of the bill.
14. **The University will not entertain any joint bidding (by two or more vendors).**
15. The bidder has to take enough care to check misutilization/improper /unauthorized use of the networking equipments.
16. **The Vendor must provide all replacements of defective spares (Cambium AP, Cambium PoE, Cambium P2P, Hp Giga Port etc.) of same make and model only during the comprehensive AMC.**
17. **The Vendor have to provide minimum 5 no AP with its PoE and other network equipments of same make and model for backup purpose.**
18. **The vendor must include deputation of a Diploma/B. Tech. qualified and technically certified dedicated site engineer having minimum 5 to 6 yrs of experience of similar work. The Bidder must submit the photo copies all the technical qualification with work experience certificates of proposed engineer.**

19. After finalization of the bid, the bidder has to enter into an agreement with Sambalpur University. Dispute if any will be subject to legal jurisdiction of Odisha only.
20. The Deputy Director, e-Governance Nodal Centre, Sambalpur University will be the single point contact for all purposes.
21. The bidder has to have prior permission of the University before making any alteration to the existing network, should there be a need for such alteration.
22. All the documents should be enclosed with a sealed envelope and must be superscripted as "Comprehensive AMC of Wi-Fi Network installed in Sambalpur University, Ref. No. 075 /17-18/e-Gov. dated 06/03/2018".
23. The payment shall be made 50% of the total cost in advance during each half of the AMC period as per the University norms.
24. The bidder should also quote for extendable AMC for a period of subsequent two years i.e. for 2<sup>nd</sup> year and 3<sup>rd</sup> year.
25. The bidder must personally check the equipment and facility, make, model etc. before applying for the same and accordingly, prepare the documents.
26. Apart from the above, the vendor may quote for any other additional items or facilities with justification and cost.
27. After finalization of the bid, the bidder has to enter into an agreement with Sambalpur University. Dispute if any will be subject to legal jurisdiction of Sambalpur only.
28. The University shall have the rights to alter, modify or delete any term and condition before the agreement is signed.
29. The authority reserves the right to reject any or all quotations or accept any without assigning any reason thereof.

The quotations complete in all respect should only be considered, so the vendors are required to visit the University Campus for their convenience before submission of their proper quotations. The bids will be opened in presence of the vendors which will be intimated by email. The vendors should also furnish their local address, email, contact nos etc. For more details please contact to the Deputy Director, e-Governance Nodal Centre, Sambalpur University during 11 AM to 5 PM in working day only.
