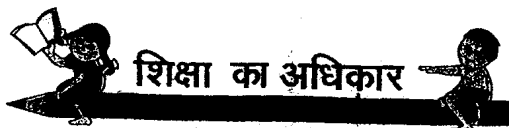
Dear Sir/Madam,

As you may be aware, the Ministry of Human Resource Development has initiated a web based 'All India Survey on Higher Education (AISHE)' to create a robust and sound data base on the large and diverse system of higher education in the country. A dedicated portal <http://aishe.gov.in> has been created for this purpose, where all the required documents including e-version of Data Capture Format are available for the State/institute level users. Using the data collected through this survey, All-India, State, University and College level reports could be generated for a better understanding of situation of education. All these reports are available to the nodal officer of the University and can be used for making informed policy decisions. The survey covers information on enrolment at various levels, human resources, infrastructure, income and expenditure etc. for all types of institutions engaged in higher education - arts, science, agriculture, teacher education, management, engineering including polytechnics, medical and nursing.

Presently survey for both the years 2011-12 and 2012-13 are under progress. Last date for submission of 2011-12 data is 30th November, 2013 and for 2012-13 data is 31st March, 2014. You may also be aware that Dr. Tushar Das has been appointed as nodal officer in the University for coordinating the activity. Role of affiliating university is very important as they have to perform the dual role (i) To collect and upload the data in respect of the university (DCF-I) and (ii) To coordinate and facilitate the survey work relating to colleges affiliated with the university. Keeping this in view, it is also proposed to create AISHE cell in each of the Affiliating University. Necessary provision to strengthen the cell is under advance stage of consideration at MHRD level.

It has been observed that the response from Colleges affiliated with the university is not very encouraging. The details of the data uploaded on AISHE portal by colleges are shown below
