" Any registered student of the University , who have been assigned the roll number by the university may be admitted to any semester examination for the Bachelor's Degree in Arts / Science / Commerce."
- ii. That in provision 5.1, the percentage of marks "33-39" under '4' Grade point in the table be replaced with "30-39". Further "below 33 or absent" be replaced by "30 or absent" under O Grade point.
- iii. That the provision 2.7 be deleted and replaced by the following ;-
"further a student ,who could not appear at the university examination due to shortage of attendance shall be allowed to sit in the following semester examination without break".
